EXECUTIVE SUMMARY:

Two bids were received for Contract ENG-2010-10 Road Resurfacing Midland Ave., Latimer Rd., Westbrook Rd., Elizabeth Ave., and Widening and Road Surfacing on Andersen Drive and Traffic Calming (Various Streets). In accordance with the City's Purchasing Policy, Council's approval is required when less than three (3) bids are received.

RECOMMENDATION:

THAT the tender of Coco Paving Inc. for the Contract ENG-2010-10 Road Resurfacing Midland Ave., Latimer Rd., Westbrook Rd., Elizabeth Ave., and Widening and Road Surfacing on Andersen Drive and Traffic Calming (Various Streets), in the amount of \$915,000.00 (plus HST) be accepted, it being the lowest tender received.

Coco Paving Inc is a reputable Contractor and has completed similar contracts for the City in the past. The bid received from Coco Paving Inc. is within the amount budgeted by the City for the completion of this project. Reference Program 90308.
