SUBJECT: Amendment to the Fees and Charges By-Law 2005-10

EXECUTIVE SUMMARY:

The fee schedule attached to By-Law 2005-10, "A By-Law to Establish Fees and Charges to be Collected by the Corporation of the City of Kingston, as amended", is updated annually. This process was completed for 2010 on December 15, 2009 and was amended on February 17, 2010. A further amendment to reduce the morning ice fee charged is required to be made to the fee schedule.

THAT a by-law be presented to amend By-Law No. 2005-10 "A By-Law to Establish Fees and Charges to be Collected by the Corporation of the City of Kingston" due to the reduction of morning ice fees at the INVISTA Centre.

BY-LAW NO. 2010-XXX

A BY-LAW TO AMEND BY-LAW NO. 2005-10 "A BY-LAW TO ESTABLISH FEES AND CHARGES TO BE COLLECTED BY THE CORPORATION OF THE CITY OF KINGSTON", AS AMENDED
(Reduction of INVISTA Centre's Morning Ice Fees)

PASSED:

The Council of the Corporation of the City of Kingston hereby enacts as follows:

1. By-Law 2005-10 of the Corporation of the City of Kingston entitled "A By-law To Establish Fees and Charged to be Collected by the Corporation of the City of Kingston, As Amended" is hereby amended as follows:

BY CHANGING the Non Prime or School Fee; Youth and Adult (current fee is \$129/hour) to \$100/hour.
2. This By-law shall come into force and take effect on the date of its passing.
