A By-Law To Appoint Municipal Law Enforcement Officers Of The Corporation Of The 'New' City Of Kingston

Passed: January 6, 1998

Whereas pursuant to Section 15 of the Police Services Act, R.S.O. 1990, c.P.15, the Council of The Corporation of the City of Kingston may appoint one or more municipal law enforcement officers who shall be peace officers for the purpose of enforcing the By-Laws of the municipality;

Therefore the Council of The Corporation of the City of Kingston enacts as follows:

1. The following persons are hereby appointed as municipal law enforcement officers of The Corporation of the City of Kingston to enforce all By-Laws of The Corporation of the City of Kingston, which includes the By-Laws from the 'former' City of Kingston, Township of Kingston and Township of Pittsburgh:
