City of Kingston By-law Number 2005-10 “Fees and Charges”

A By-Law To Establish Fees And Charges To Be Collected By The Corporation Of The City Of Kingston

Passed: December 14, 2004

Whereas the Municipal Act, 2001, S.O. 2001, provides that a municipality may pass by-laws imposing fees or charges on any class of persons; and,

Whereas the Planning Act, being Chapter P. 13 R.S.O., 1990 as amended, provides that Council may prescribe a tariff of fees for the processing of applications made in respect of planning matters; and,

Whereas pursuant to the Building Code Act, 1992, S.O. 1992 c 23 as amended, Council may require the payment of fees on applications for and issuance of building permits and prescribing the amounts thereof, and,

Whereas the Corporation of the City of Kingston deems it expedient to consolidate and update the fees and charges to be collected by the various departments of the Corporation of the City of Kingston,

Now Therefore the Corporation of the City of Kingston hereby enacts as follows:

1. Council hereby establishes the fees and charges as set out in Schedule A to this by-law for The Corporation of the City of Kingston (Kingston). The fees and charges will be subject to Harmonized Sales Tax (HST) and Retail Sales Tax (RST), where applicable.

2. (a) That That fees and charges shall be adjusted annually, on January 1, by the Consumer Price Core Index of the third quarter of the prior year plus 1% for capital purposes, where feasible.
(By-law Number 2005-10; 2007-84; 2007-191)
- (b) That in those instances where the fee is not adjusted by the Consumer Price Index composite index in one year, the cumulative adjustment for past years may be made in future years, as approved by council.

- (c) Deleted by By-law Number 2010-10)
3. Despite paragraphs 2(a) and (b), fees and charges may be adjusted, as approved by council, to recover at a minimum, respective service, administration and capital costs, as well as costs for any other purpose in any amount permitted under applicable law.

4. Payment is received at the time of the transaction for which the fee or charge is imposed, or upon the due date specified in the terms of a contract signed by the City or an invoice issued by the City.

5. (a) That any portion of a fee or charge that remains unpaid beyond the date fixed for payment shall bear interest at the rate of 1.25% (15% per annum) after thirty (30) days and each month thereafter until such fee or charge is paid in full.

- (b) That Kingston may use a registered collection agency to collect any unpaid fee or charge, including interest charged pursuant to section 4 and the collection agency’s fees, as approved by Kingston, shall be added to the unpaid amounts to become the total amount payable to the collection agency.

6. That the treasurer shall add unpaid fees and charges imposed by the municipality to the tax roll for the following property in the City of Kingston and collect them in the same manner as municipal taxes:
 - (a) In the case of fees and charges for the supply of a public utility, the property to which the public utility was supplied.
 - (b) In all other cases, any property for which all of the owners are responsible for paying the fees and charges.

7. That where this by-law established a fee and charge for a fee that also exists in another by-law that predates the effective date of this by-law, the fee and charge in this by-law shall be the applicable fee and charge and the other by-law is hereby effectively amended.

8. In the event that by-law 2005-10, as amended, is repealed and re-enacted or amended in its entirety, it shall be assigned the same by-law number, due to the fact this by-law is mentioned in several other related by-laws.

City of Kingston By-law Number 2005-10 “Fees and Charges”

9. Should any part of this by-law, including any part of any schedule, be determined by a court of competent jurisdiction to be invalid or of no force and effect, it is council's intention that such invalid part of this by-law shall be severable and that the remainder of this by-law including the remainder of the impugned schedule, as applicable, shall continue to operate and to be in force and effect.

10. That the Chief Financial Officer/City Treasurer be delegated the authority to waive fees for not-for-profit organizations requesting the use of municipal facilities as defined in the Waiver of Fees Policy.

Rules for Determining Permit Fees:

- Floor area of the proposed work is to be measured to the outer face of exterior walls (excluding residential attached garages) and to the centre line of party walls, firewalls or demising walls.
- In the case of interior finishes, alterations or renovations, area of proposed work is the actual space receiving the work, e.g. tenant suite.
- Mechanical penthouses and floors, mezzanines, lofts, habitable attics and interior balconies are to be included in all floor area calculations.
- Except for interconnected floor spaces, no deductions are made for openings within the floor area (e.g. stairs, elevators, escalators, shafts, ducts, etc.).
- Unfinished basements for single detached dwellings, semi-detached dwellings and townhouses are not included in the floor area.
- Where Demolition of partitions or alterations to existing ceilings are part of an alteration or renovation Permit, no additional charge is applicable.
- Corridors, lobbies, washrooms, lounges, etc. are to be included and classified according to the major occupancy for the floor area on which they are located.
- The occupancy categories in this Schedule correspond with the major occupancy classifications in the Ontario Building Code. For multiple occupancy floor areas, the Permit fees for each of the applicable occupancy categories may be used, except where an occupancy category is less than 10% of the floor area.
