**Whereas** opioids, include hydromorphone, oxycodone, fentanyl, carfentanyl, morphine, and heroin are a class of drug used primarily for pain relief; and

**Whereas** Canada is among the top prescribers of opioids in the world, and Ontario has the highest opioid-dispensing rates in the country with nearly 2 million Ontarians dispensed an opioid in 2014/15, which totalled approximately 9 million dispenses putting roughly 15% of Ontarians on prescription opioids ; and

**Whereas** opioids act as depressants on the respiratory system, which can slow or stop breathing, and lead to overdose and death if misused; and

**Whereas** opioids are also accessed illicitly, either through diverted prescriptions or through the illegal drug market resulting in community crises in many parts of Canada and Ontario; and

**Whereas** there has been an increase in opioid-related emergency department visits and admissions to hospital in Kingston and confirmed cases of both bootleg fentanyl and carfentanyl in the KFL&A region; and

**Whereas** the presence of opioids such as fentanyl and the even stronger carfentanyl in the KFL&A and other illegal drug markets is concerning because Fentanyl can be 50 to 100 times more toxic than morphine, and even tiny amounts - the equivalent to one or two grains of salt - can cause overdose and death; and

**Whereas** fentanyl and carfentanyl are being illegally mixed into a range of other drugs, such as heroin, cocaine, counterfeit pills such as Percocet and oxycodone, and cannabis increasing the risks that individuals can unintentionally consume these powerful opioids increasing their risk of overdose and death; and

**Whereas** KFL&A community partners are developing a comprehensive community response to tackle the opioid crisis that focuses on prevention, treatment, harm reduction, enforcement and surveillance; and

**Whereas** a comprehensive approach to reduce the morbidity and mortality from opioid intoxication and overdose includes increasing the availability of Naloxone in the community; and

**Whereas** Naloxone is a medication that can temporarily reverse an overdose caused by opioid drugs, and can save a life by keeping an individual alive while they wait for emergency support to arrive; and

**Whereas** increasing naloxone availability is a key harm reduction initiative in a local community response;

**Therefore Be It Resolved That** the City of Kingston endorse the distribution Naloxone Kits to all public institutions and an education and training program on how to use them as part of a Community Drug Policy; and

**That** all City funded organization be formally asked to participate and have available Naloxone Kits and the training to use them including clear precautions stating "recipients of naloxone may become instantly hyper-alert, and/or violent."; and

**That** the City of Kingston encourage the provincial government through the responsible Ministers to work together to make Naloxone Kits easily available in all public institutions, and that the province enact legislation and regulations as needed to limit the liability on non-paramedic responders when administering the drug to treat an overdose; and

**That** this resolution be forwarded to all municipalities in Ontario, with a population greater than 40,000, with the request that they consider indicating their support for this most important initiative; and

**That** this resolution be forwarded to the Association of Municipalities of Ontario, with the request that they include proposing a community drug policy that includes access to Naloxone in their respective engagements with the provincial government; and

**That** this resolution be shared with the Premier of Ontario, all opposition leaders, the ministers of health and Long-Term Care, opposition health critics, our local MPPs, the four school boards, and all city funded organizations; and

**That** the Government of Ontario consider measures to immediately and directly address the over-prescription of legal narcotics by licensed physicians.

To the Mayor and Members of Council:

The Chief Administrative Officer reports and recommends as follows:

**1. Seniors Association Kingston Region - Amendment to Lease Agreement**

**That** Council forgive, as of January 1, 2018, the outstanding loan totalling \$129,576 owed by the Seniors Association Kingston Region, incurred for the acquisition and upgrade of 56 Francis Street in 2001; and

**That** the amount of \$129,576 be funded from the Working Fund Reserve; and

**That** Council terminate the existing lease dated December 15, 2000 and repeal By-Law Number 2013-96 effective January 1, 2018; and

**That** Council authorize the Mayor and the Clerk to terminate the existing lease and execute a new lease agreement with the Seniors Association Kingston Region to commence January 1, 2018 for a period of 20 years, for the base rent of \$1 per year, in a form satisfactory to the Director of Legal Services; and

**That** as required by clause 6(1)(b) of Ontario Regulation 603/06, it be confirmed that the Seniors Centre at 56 Francis Street is a municipal capital facility to be entirely occupied for recreation purposes of the municipality and that it is operated for public use; and

**That** in accordance with Section 110(6) of the *Municipal Act*, 2001, the by-law attached as Exhibit A to Report Number 17-277, being a By-Law to Authorize an Agreement for the Provision of a Municipal Capital Facility at 56 Francis Street, Kingston, Ontario, be presented, it being understood that this by-law will provide an exemption to the property to which the Municipal Capital Facility Agreement applies, from taxation for municipal and education purposes, and will provide a \$129,576 grant to eliminate the principle on an outstanding loan to the City; and
