

**City of Kingston 2018 Municipal Election
Preliminary Certificate of Maximum Campaign Expenses/Contributions to a Candidates'
Own Campaign as of the Filing Date of the Nomination**

In accordance with Sections 33.0.1 and 33.0.2 of the *Municipal Elections Act, 1996* (the Act), the following are the maximum amounts of a nominated person's expenses for the offices outlined below, for the Municipal Election to be held on October 22, 2018. These amounts have been determined by using the total eligible electors (85,738) from the Voters' List from the 2014 Municipal Election, as it existed on Nomination Day of the 2014 Municipal Election adjusted for applications under Sections 24 and 25 of the Act that were approved as of that day (Section 88.20 (15)).
