

## Final Certificate of Maximum Campaign Expenses

In accordance with subsection 88.20 (13) of the *Municipal Elections Act, 1996*, the Clerk shall calculate the maximum amounts of campaign expenses permitted by subsections 88.20 (6) and (9) and provide a Certificate for each office for which Nominations were filed. The Certificate of Maximum Amounts is to be provided on or before September 25<sup>th</sup> in the case of a Regular Election.

In accordance with subsection 88.20 (15) of the *Municipal Elections Act, 1996*, for the 2018 Municipal Election the Maximum Amounts are to be determined from the Voters' List for the 2014 Municipal Election as it existed on Nomination Day of the 2014 Municipal Election, adjusted for applications under Sections 24 and 25 of the Act that were approved as of that day (83,005 electors).
