Subject: Minor By-law Revision for Posted Speed Limits – Various Locations

Executive Summary:

The April 2, 2019 report approved by Council titled, "Road Safety Enhancements – Various Locations" included a minor error in the proposed revisions to By-law 2003-209, "*A By-law For Regulating Traffic in the Highways of the City of Kingston, Subject To the Provisions of the Highway Traffic Act*".

Prior to posting the approved speed reductions, sections 1.1 and 1.2 of By-Law 2003-209 need to be corrected in Exhibit A such that Schedule A-4 is changed to Schedule A-5.

Recommendation:

That a by-law be presented to amend By-law Number 2003-209, being a "*A By-law For Regulating Traffic in the Highways Of The City of Kingston, Subject To The Provisions Of The Highway Traffic Act*" as amended, as per Exhibit A to Report Number 19-141.



Options/Discussion:

Report 19-096 - Road Safety Enhancements – Various Locations, was approved by Council on April 2, 2019 and recommended improvements at various locations in relation to all-way stop control, posted speed limit reductions, prohibiting trucks on a particular route, and banning U-turns at an intersection.

This report included a minor error in Exhibit A under By-law 2003-209, "*A By-law For Regulating Traffic in the Highways of the City of Kingston, Subject To the Provisions of the Highway Traffic Act*" related to the reduction of the posted speed limits on sections of Henderson Boulevard, Dagleish Avenue, Kirkpatrick Street, and Kingston Road 38.

To correct By-law 2003-209, sections 1.1 and 1.2 of the by-law need to be changed in Exhibit A such that Schedule A-4 becomes Schedule A-5. The approved posted speed limits are the same as those approved under Report 19-096.

The City has already begun installing signage related to the other safety initiatives in the April 2 report. Crews will be required to wait until the recommended by-law revisions related to the posted speed limits in this report have been approved by Council to install the new speed limit signage.

A By-law to Amend By-law Number 2003-209 “A By-law to Regulate Traffic”

Passed: Meeting date, 2019

The Council of The Corporation of the City of Kingston hereby enacts as follows:

1. By-law Number 2003-209 of the Corporation of the City of Kingston entitled “A By-Law to Regulate Traffic, Subject to the Provisions of the Highway Traffic Act”, as amended, is hereby further amended as follows:
 - 1.1 Schedule A-5, Highways with a Limit of 40 kilometres per hour, is hereby amended by removing the following there from:
Henderson Boulevard from Roosevelt Drive to Glen Castle Road
 - 1.2 Schedule A-5, Highways with a Limit of 40 kilometres per hour, is hereby amended by adding the following thereto:
Dalglish Avenue from Gore Road to Donald Street

Henderson Boulevard from Days Road to Bayridge Drive

Kirkpatrick Street from Division Street to Brant Avenue
 - 1.3 Schedule A-2, Highways with a Limit of 70 kilometres per hour, is hereby amended by adding the following thereto:
Kingston Road #38 from Mclvor Road to 50 metres North of Bur Brook Rd
2. This By-law shall come into force and take effect on the date of its passing.
