The Council of the Corporation of the City of Kingston enacts as follows:

1. By-law 2009-76, entitled “A By-Law to Provide for the Regulation Use of Parks and Recreation Facilities of the Corporation of the City of Kingston”, as amended, is hereby further amended as follows:

- 1.1 Section 25 is hereby amended by **replacing** “Kingston Cancer Clinic” with “Cancer Centre of South-Eastern Ontario at KGH”, and by **adding** the following thereto: “and to display a valid Pay and Display receipt”, so that the section shall now read as follows:

“A motor vehicle displaying a valid parking permit issued to a patient by the Cancer Centre of South-Eastern Ontario at KGH and a valid Pay and Display receipt shall be exempt from the regulation prohibiting parking a motor vehicle unattended in City Park.”

2. This by-law will come into force and take effect on July 3, 2012.
