Payment options

Due to the potential mail strike, we recommend choosing an alternative payment method. Late payments are subject to penalty.

You may also join the Pre-Authorized Payment Plan. This plan is a convenient, worry-free, and secure option to pay property taxes over 10 monthly installments. Tax payment receipts

Receipts are available by mail when you enclose a self-addressed stamped envelope with your tax bill. You may also present your tax bill to have it stamped "paid".

Assessment and tax appeal information

The Ontario government continues to postpone the previously scheduled 2020 Assessment Update while they conduct a property assessment and taxation review. The province has indicated that property assessments for the 2025 taxation year will continue to be based on the fully phased-in January 1, 2016 current values (i.e., the same valuation date that has been in use since 2020). If you have questions about your property assessment contact the MPAC at 1-866-296-6722 or visit **mpac.ca**

If your property has undergone changes, you may be eligible to apply for a tax adjustment. For information and applications please go to **CityofKingston.ca/Tax**. Please note that taxes must be paid even if you are appealing your assessment. The City has no authority to cancel interest beyond the amount of tax reduction achieved if your appeal is successful.

University Hospitals Kingston Foundation, City of Kingston external agencies and County of Frontenac 2025 levies

As per Council direction, amounts levied for the University Hospitals Kingston Foundation as well as the amounts levied for City of Kingston external agencies and the County of Frontenac for the City's share of Frontenac Paramedic and Fairmount Home for the Aged services are billed as separate components on the property tax bills.
