Candidate Compliance with Filing Requirements*Municipal Elections Act, 1996, s.88.25, s. 88.23(4)*

In accordance with section 88.25 of the Municipal Elections Act, 1996 (the “MEA”), all nominated candidates, including those who later withdrew their nomination, must disclose and report any contributions and expenses during their campaign period by filing a financial statement. A separate financial statement is required for each office for which the candidate was nominated.

Pursuant to subsection 88.23(4) of the MEA, this report sets out all candidates in the 2022 Municipal Elections and indicates whether each candidate complied with section 88.25 of the MEA.

Candidates that failed to file a financial statement and auditor’s report by March 31, 2023 (or by 2 p.m. on May 1, 2023, the day that is 30 days after the applicable day for filing the documents) are deemed to be in default. In accordance with subsection 88.23(2) of the MEA, such candidates forfeit any office to which they were elected and are ineligible to be elected or appointed to any office to which the MEA applies until the next regular election has taken place.

Set out below in Appendix “A” is a list of all nominated candidates in the 2022 Municipal Elections. Candidates are listed by office, as follows:

- Mayor
- Councillor
- Limestone District School Board Trustee
- Algonquin Lakeshore Catholic District School Board Trustee
- Conseil des écoles publiques de l’Est de l’Ontario Trustee; and
- Conseil des écoles catholiques du Centre-Est Trustee.
